The Egyptian International Pharmaceutical Company - EIPICO announced the signing of a cooperation agreement with the Greenmia Alliance and EL Square, in the presence of Dr. Olfat Ghorab, President of Accima Company, and Dr. Ahmed Kilani, Chairman and Managing Director of EIPICO Pharmaceutical Company. Through this agreement, EIPICO aims to implement the technologies of the Fourth Industrial Revolution and the steps it requires for a comprehensive digital transformation of the elements of production lines, supply chains and warehouses through the use of global technical expertise in this field. The **EIPICO Pharma 4.0** project comes Within the framework of the development of the company's technological infrastructure and to keep pace with the state's directions in settling the pharmaceutical industry in Egypt through the application of the latest global technological methods, with investments of about 20 million pounds, an annual saving of no less than 30 million pounds was achieved after its implementation.

EIPICO is the first Egyptian pharmaceutical company to enter this field in Egypt and the Middle East, through this promising project for the digital transformation of the production lines, which number about 43 production lines in the company, using the latest technologies of artificial intelligence, **Robots** and **"Internet of Things technology. – IOT"** to digitize the entire production process, take measurements and record readings automatically and in real time with machine control, integrated analysis of all elements of the production process, and even forecast malfunctions in production lines or facilities and alerting to take the necessary to avoid their occurrence in advance, which prevents The occurrence of any stage of production, reduces costs and maximizes the optimal use of raw materials, devices, production lines and energy used.

Commenting on the agreement, Dr. Ahmed Kilani stated that this project will be linked with the company's ERP system to achieve homogeneity between all departments, to maximize benefit from the project and improve the decision-making mechanism, and achieve many strategic benefits represented in the full application of the principles of governance and the use of technology in achieving the company its economic objectives, taking into account the social and environmental dimension, without compromising the opportunity of future generations to achieve their goals, but rather opening many areas for them in line with the goals of sustainable development.

This agreement comes as a continuation of EIPICO's vision of a comprehensive digital transformation, financially and administratively, as there is currently agreement with the state in the system of issuing electronic invoices, as well as the system of pre-registration of customs shipments and tax and insurance transactions digitally.
