**Share name**: Orascom Construction PLC – AEDFXA14NUL7 (Nasdaq Dubai) and EGS95001C011 (The Egyptian Exchange). There is only one class of shares; all shares are ordinary and carry 1 voting right each.

The Sawiris Family members and entities held for their benefit continue to own a total of 60,481,391 shares, representing 51.80% of total issued shares of Orascom Construction PLC.

By 6 September 2022, all 15,026,024 shares, representing 12.87% of total issued shares, held by OS Private Trust Company Limited were transferred to other entities held for the benefit of members of the Sawiris Family:

- Entity held for the benefit of Mr. Nassef Sawiris: received 6,439,725 shares, representing 5.52% of total issued shares. Prior to this share transfer, the ownership level was 33,825,323 shares, representing 28.97% of total issued shares.
- Entities held for the benefit of Mr. Samih Sawiris and his family members: received 2,146,574 shares, representing 1.84% of total issued shares. Prior to this share transfer, the ownership level was 11,630,044 shares, representing 9.96% of total issued shares.
- Entity held for the benefit of Mr. Naguib Sawiris and his family members: received 6,439,725 shares, representing 5.52% of total issued shares. There was no ownership prior to this share transfer.

These share transfers have no impact on the total number of shares owned by the Sawiris Family members and entities held for their benefit. There is also no price associated with these share transfers.

Following these share transfers, the breakdown of the total shares held by the Sawiris Family and entities held for their benefit in Orascom Construction PLC is shown below:
