The project also offers various services and facilities including a community center that includes a multi-purpose sports court, a swimming pool, a football court, and fitness centers, in addition to healthcare services and educational programs. Kinda is also known for exhibiting world-class sustainability standards, especially in terms of rationalizing energy consumption. In addition to Kinda, MNHD has other administrative projects that are located inside Taj City.
