Income statement:

Net profit after taxes for the financial period ended 30 June 2023 amounted to 4.7 billion EGP compared to 2.8 billion EGP for the same period of 2022 due to:

- Increase the company's share of subsidiary's dividends by 901 million EGP for the same period of 2022.
- Increase in foreign currency translation differences by 1.1 billion EGP compared to the same period of 2022.

Balance sheet:

Total Equity for the financial period ended 30 June 2023 amounted to a value of 12.2 billion EGP compared to 11.1 billion EGP due to:

- Increase in Retained Earnings for the financial period by 933 million EGP for 2022.
